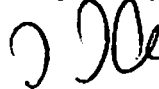

Fresh Youth Initiatives (FYI) exists because young people in our neighborhood need safe, structured, positive activities in the non-school hours. FYI approaches youth as potential resources (not as problems or clients) in meeting community needs, and supports a youth-centered approach in helping youth take positive action. For instance, FYI runs the Helping Hands Food Bank (feeding 200 families each month), which is the brainchild of a 16 year-old FYIer. Other youth-led service projects include making sleeping bags for homeless individuals, painting the apartments of seniors, cleaning local parks, and running a mobile clothing bank.

Community Youth in Action - Supports young people, ages 9-19, as they create, develop and implement their own community service activities, participate in retreats, immerse themselves in the concept of community service and hold public events to present their work and its results.

Helping Hands Food Pantry provides bags of canned goods twice per month to neighbors and other in need of food assistance. Youth also make home deliveries of canned goods to those too infirm to come to the HHFP and pick up the food.

Mentoring - Matches up adult role models with youth participants, with the adults giving guidance, advice and academic help to the mentees. FYI utilizes technical

assistance from Big Brothers/Big Sisters and the Mentoring Partnership of NYC to provide ongoing training for the mentors.

Career Awareness - FYI participants take part in Take Our Daughters and Sons to Work Day, Groundhog Job Shadow Day, and other activities (resume preparation, coaching on job interviews) to best be prepared to enter the workforce.

Summer of Service - FYI operates a summer camp for younger participants that combines services, activities, recreation, culture, and fun.

Parents in Action - FYI gathers parents of participants each month to support them in their efforts to strengthen lives of their children. Almost every meeting features a workshop on topics relating to child development and family strengthening.
